

**“Delivery Man” Promotion

Official Rules**

SPONSOR

This promotion, titled the “Delivery Man Promotion,” is sponsored by TaskRabbit, Inc. (“**TaskRabbit**”), the owner and operator of www.TaskRabbit.com (the “**Website**”).

ELIGIBILITY

The promotion is open to all legal residents of the states of California, New York, Illinois, and Massachusetts who are 18 years of age or older. Offer void wherever prohibited or restricted by law.
