Official Rules

No Purchase Necessary. A purchase will not increase your chances of winning.

This promotion is in no way sponsored, endorsed or administered by, or associated with, Facebook, Twitter, Instagram, or any other social network or platform. You understand that you are providing your information to Sponsor, and not to, Facebook, Twitter, Instagram, or other social network or platform.

- 1. ELIGIBILITY.** The TaskRabbit #ATinyTask photo contest (“Contest”) is open to legal residents of the United States (the “Select Markets”), who are lawful U.S. residents, are 18 years of age or older at the start of the Contest, and have internet access (“Entrants”). Contest is sponsored by TaskRabbit, Inc., 425 Second Street, 5th Floor, San Francisco, CA 94107 (“Sponsor” or “TaskRabbit”). Employees of Sponsor, its parents and subsidiaries, advertising and promotion agencies and all other entities participating in the design, promotion, marketing, advertising, administration or fulfillment of this Contest and their immediate families are ineligible to participate in this Contest. Void wherever else restricted or prohibited by law. By participating in this Contest, each Entrant hereby acknowledges that they have read, accept and agree to be bound by these Official Rules.
- 2. CONTEST PERIOD.** The Contest begins at 5:00 p.m. Pacific Standard Time (“PST”) on May 16, 2016 and ends at 11:59 p.m. PST on May 22, 2016 (the “Contest Period”).
- 3. HOW TO ENTER.**

Online. To enter online, Entrants must do the following:

- 1) Follow TaskRabbit’s Instagram account @taskrabbit.
- 2) Swing by the TaskRabbit Tiny House being built in New York City May 16th – May 19th and snap a photo or video of the house or the "For Sale" sign out front. We're looking for the MOST fun, creative photos or videos with our Tiny House.
- 3) Share your picture via Instagram, Twitter, or Facebook, tag @taskrabbit and use the official contest hashtag #atinytask in order to be eligible.

Once this has happened, the Client will automatically be entered into the Contest as an Entrant. Registration is free and is subject to Sponsor’s Terms of Service found at <https://www.taskrabbit.com/terms> (“Terms of Service”) and Privacy Policy, found at <https://www.taskrabbit.com/privacy>. Your social media account (or the applicable photo) must be set to public in order to be seen by Sponsor and eligible. Instagram, Twitter and Facebook (the “Promotion Platforms”) are all free and may accessed online or an application may be downloaded through a mobile application store. The terms “Tasker” and “Task” are as defined in the Terms of Service.

The photo and all other entrant-provided entry material and information are collectively referred to herein as a “Submission” or “Submissions.” Incomplete Submissions will be rejected.

There is no limit to the number of entries a person may enter in the Contest.

Submission Requirements. All contact information provided must be valid, current and complete. All entries must be received by 11:59 p.m. PST on May 20, 2016 according to Sponsor's server clock. No hand or postal mail entries will be accepted. Incomplete, garbled, corrupted or otherwise illegible entries are void and will not be accepted. All entries submitted become the sole property of Sponsor and will not be acknowledged or returned. Sponsor reserves the right to disqualify false entries or entries suspected of being false. Entries generated by a script, macro or other automated means will be disqualified. In the event of a dispute as to the identity of an Entrant, the Entrant will be deemed to be the person in whose name the e-the social media account is registered to, if available. In the event a dispute regarding the identity of the individual who actually submitted an entry cannot be resolved to Sponsor's satisfaction, the affected entry will be deemed ineligible. The Sponsor shall determine, in its sole discretion, if any entrant shall be disqualified for any reason, and all decisions of disqualification by the Sponsor are final.

All Submissions should be the original, unpublished and sole work of the respective Entrant. By entering, all Entrants warrant and represent that (a) their respective Submissions are their own fully original creations, (b) their respective Submissions (including, but not limited to, any materials integrated into their Submissions) will not infringe or violate the rights of any third parties, including but not limited to copyrights, trademarks and/or rights of publicity/privacy, (c) any third party whose person or property appears in the Submission has given Entrant appropriate written consent (which shall be provided to Sponsor upon request thereof) for such person or property to be photographed and used as permitted herein, and (d) their respective Submissions will not disparage Sponsor or any other person or party, or contain material that is inappropriate, indecent, obscene, violent, hateful, tortious, defamatory, slanderous or libelous. Sponsor reserves the right to reject, not post for public viewing, and disqualify from the Contest any Submission that it deems, in its sole discretion, to be inappropriate, for any reason.

4. **PUBLICITY.** Entrants grant to Sponsor the right to use and publish their social media handle and photo submission in print for promotional or advertising purposes in connection with the Contest on a worldwide basis, and in all forms of media, now or hereafter known, in perpetuity, without review, permission or further compensation. With image submission tagging @taskrabbit and using the official contest hashtag #atinytask, each Entrant grants Sponsor royalty-free license to display, retain and modify all images submitted. All images will be credited with the name or social media handle of Entrant.

SELECTION AND NOTIFICATION OF WINNER. Sponsor will select one grand prize winner (the "Grand Prize Winner") and five (5) honorable mention winners (each a "Honorable Winner", and together with the Grand Prize Winner, the "Winners") who will be selected by a panel of judges consisting of selected individuals from Sponsor's marketing team, based equally upon the criteria of skill, originality, and relevance. Sponsor reserves the right to judge which photo is the winning submission. Odds of winning a prize depend on the number of eligible entries received. The decisions of Sponsor are final on all matters relating to this Contest. Each Winner will be notified by the official @taskrabbit account associated with the social media platform used to post the winning photos by May 25, 2016 ("Notification"). Each Winner will be required to respond (as directed) within twenty-four hours after attempted Notification. Each Winner's failure to respond timely to the Notification may result in forfeiture of a prize, and in such case, Sponsor may select an alternate Winner from among the remaining eligible entries. Winners may be sent a

declaration of eligibility / liability / publicity release (“Release”). Except where prohibited by law, the Release will state that a Winner agrees to allow Sponsor to use (without additional compensation) his or her name, address, photograph, testimonial, likeness and/or biographical information for purposes of advertising and promotion (including, without limitation, posting on Sponsor’s website(s) and affiliated website(s)). Unless restricted by law, Winners will be required to complete and return the Release within the time period specified therein. A prize may be forfeited, and in such case, an alternate Winner may be randomly selected from among the remaining eligible entries if a Winner (up to three times): (i) cannot be reached; (ii) does not respond to the Notification in a timely manner as required pursuant to these Official Rules; (iii) fails to obtain all signatures on the Release and to return the documents in a timely manner as required pursuant to these Official Rules; or (iv) cannot accept or receive a prize for any reason. Non-compliance with these Official Rules may result in disqualification and selection of an alternate Winner. The first and last name, social media handle, hometown, state, name of business and company logo of Winner may be announced and posted on Sponsor’s and its affiliates’ online websites and social media pages (such as Facebook, Twitter, and Instagram) and may potentially be aired or streamed nationally, in Sponsor’s discretion.

If eligible under these Rules, each Honorable Winner will each be awarded the following award (the “Honorable Prize,” and together with the Main Prize, each a “prize”): a \$25 TaskRabbit Gift Certificate, a \$50 Target Gift Certificate, and a \$25 Home Depot Gift Certificate.

Form of payment and delivery of all prizes above (e.g. cash, check, gift card, reimbursement, etc.) shall be at Sponsor’s sole discretion. Total Approximate Retail Value (“ARV”) of the prizes are as stated above. Gift cards and vouchers subject to the applicable stores’ terms of use (including the Terms of Service).

- 3. DISPUTES.** Disputes regarding these Official Rules and/or this Contest will be governed by the internal laws of the State of California. By entering, you consent to jurisdiction in San Francisco, California for the resolution of any and all disputes. Should a dispute arise regarding the Contest, Entrant and Sponsor shall engage in good faith, informal dispute resolution for a minimum period of thirty (30) days to resolve the dispute. Should the Entrant and Sponsor fail to resolve their dispute informally, they shall engage in mediation with JAMS, at their joint and equal expense. Should the mediation fail to resolve the dispute, Entrant and Sponsor shall thereafter engage in binding arbitration with JAMS. To ensure minimal cost, the arbitration shall be in front of a single arbitrator and shall be conducted in accordance with JAMS' Optional Expedited Arbitration Procedures. The binding arbitration shall be at Sponsor and Entrant's joint and equal expense, with attorneys' fees and costs to the prevailing party upon conclusion.
- 4. GENERAL CONDITIONS.** By participating, Entrants agree to be fully and unconditionally bound by these Official Rules and the decisions of Sponsor and waive any right to claim ambiguity in the Contest or these Official Rules. Any portion of the Contest may be

canceled, suspended and/or modified, in whole or in part, if in Sponsor's opinion any fraud, technical failure or other factor beyond our control impairs the integrity or proper functioning of the Contest. Sponsor reserves the right in its sole discretion to disqualify any individual who is found to be tampering with the entry process or the operation of the Contest or the Website, to be acting in violation of these Official Rules, or to be acting in an unsportsman-like or disruptive manner, or with the intent to disrupt or undermine the legitimate operation of the Contest, or to annoy, abuse, threaten or harass any other person, and Sponsor reserves the right to seek damages and other remedies from any such person to the fullest extent permitted by law. You may not enter with multiple identities or use any automated system, bot or other device or artifice to enter or obtain more than the maximum number of qualified entries. Unclaimed prizes will not be awarded.

5. **PRIVACY.** All personal information collected by Sponsor will be used for administration of the Contest. In addition, Entrants may receive email correspondence from, or on behalf of Sponsor subject to Sponsor's Privacy Policy.
