

TaskRabbit On The Move Giveaway

Official Rules

1. ELIGIBILITY.

2. The On The Move Giveaway (“Giveaway”) open only to those who sign up at the online giveaway page and who are 18 as of the date of entry (Entrants). The giveaway is only open to legal residents of US and UK and is void where prohibited by law. Giveaway is sponsored by TaskRabbit, Inc., 425 Second Street, 5th Floor, San Francisco, CA 94107 (“Sponsor” or “TaskRabbit”). Employees of Sponsor, its parents and subsidiaries, advertising and promotion agencies and all other entities participating in the design, promotion, marketing, advertising, administration or fulfillment of this Giveaway and their immediate families are ineligible to participate in this Giveaway. Void wherever else restricted or prohibited by law. By participating in this Giveaway, each Entrant hereby acknowledges that they have read, accept and agree to be bound by these Official Rules.

3. SWEEPSTAKES PERIOD.

4. The Giveaway begins at 3a.m. Pacific Standard Time (“PST”) on May 15, 2017 and ends at 11:59 a.m. PST on May 22, 2017 (the “Giveaway Period”).

5. HOW TO ENTER.

6. The Giveaway must be entered by submitting an entry using the online form provided on this Giveaway site. The entry must fulfill all giveaway requirements,

as specified, to be eligible to win a prize. Entries that are not complete or do not adhere to the rules or specifications may be disqualified at the sole discretion of TaskRabbit. You may enter only once and you must fill in the information requested. You may not enter more times than indicated by using multiple email addresses, identities or devices in an attempt to circumvent the rules. If you use fraudulent methods or otherwise attempt to circumvent the rules your submission may be removed from eligibility at the sole discretion of TaskRabbit.

7. ODDS.

8. Odds of winning a prize depend on the number of eligible entries received.

9. SELECTION AND NOTIFICATION OF SELECTED ENTRANT..

10. Winners of the Giveaway will be selected in a random drawing under the supervision of the Sponsor. The Selected Entrant will be notified by email in Sponsor's discretion ("Notification"). The Selected Entrant will be required to respond (as directed) within five days after attempted Notification. TaskRabbit shall have no liability for a winner's failure to receive notices due to winners' spam, junk e-mail or other security settings or for winners' provision of incorrect or otherwise non-functioning contact information. If the selected winner cannot be contacted, is ineligible, fails to claim the prize within 15 days from the time award notification was sent, or fails to timely return a completed and executed declaration and releases as required, prize may be forfeited and an alternate winner selected.

11. The receipt by winner of the prize offered in this Giveaway is conditioned upon compliance with any and all federal and state laws and regulations. ANY VIOLATION OF THESE OFFICIAL RULES BY ANY WINNER (AT SPONSOR'S SOLE DISCRETION) WILL RESULT IN SUCH WINNER'S DISQUALIFICATION AS WINNER OF THE SWEEPSTAKES AND ALL PRIVILEGES AS WINNER WILL BE IMMEDIATELY TERMINATED.

14. Winners will receive \$200 or £150 TaskRabbit credit. Actual/appraised value may differ at time of prize award. The specifics of the prize shall be solely determined by the Sponsor. No cash or other prize substitution permitted except at Sponsor's discretion. The prize is nontransferable. Any and all prize related expenses, including without limitation any and all federal, state, and/or local taxes shall be the sole responsibility of the winner. No substitution of prize or transfer/assignment of prize to others or request for the cash equivalent by winners is permitted. 15. CONDITIONS.

All federal, state or other tax liabilities (including income taxes) arising from this Giveaway will be the sole responsibility of Selected Entrant and Selected Entrant may be issued an IRS Form 1099 for the ARV of any awarded prize. Except where prohibited by law, the Selected Entrant's entry and acceptance of a prize constitutes permission for Sponsor to use said Selected Entrant's photograph, likeness, statements, biographical information, voice, and city and state address, as well as the name and logo of their respective business, for promotional or advertising purposes in connection with these Giveaway on a worldwide basis, and in all forms of media, now or hereafter known, in perpetuity, without review, permission or further compensation. Sponsor reserves the right to disqualify any Entrant it finds to be tampering with the entry process or the operation of the Giveaway or violating these Official Rules, and reserves the right at its sole discretion to terminate the Giveaway and, if terminated, at its discretion, select the potential winner(s) in a random drawing from among all eligible, non-suspect entries received prior to action taken. 18. Disputes regarding these Official Rules and/or this Giveaway will be governed by the internal laws of the State of California. By entering, you consent to jurisdiction in San Francisco, California for the resolution of any and all disputes. Should a dispute arise regarding the Giveaway, Entrant and Sponsor shall engage in good faith, informal dispute resolution for a minimum period of thirty (30) days to resolve the dispute. Should the Entrant and Sponsor fail to resolve their dispute informally, they shall engage in mediation with JAMS, at their joint and equal expense. Should the mediation fail to resolve the dispute, Entrant and Sponsor shall thereafter engage in binding arbitration with JAMS. To ensure minimal cost, the arbitration shall be in front of a single arbitrator and shall be conducted in accordance with JAMS' Optional Expedited Arbitration Procedures. The binding arbitration shall be at Sponsor and Entrant's joint and equal expense, with attorneys' fees and costs to the prevailing party upon conclusion.

19. GENERAL CONDITIONS.

20. By participating, Entrants agree to be fully and unconditionally bound by these Official Rules and the decisions of Sponsor and waive any right to claim ambiguity in the Giveaway or these Official Rules. Any portion of the Giveaway may be canceled, suspended and/or modified, in whole or in part, if in Sponsor's opinion any fraud, technical failure or other factor beyond our control impairs the integrity or proper functioning of the Giveaway. Sponsor reserves the right in its sole discretion to disqualify any individual who is found to be tampering with the entry process or the operation of the Giveaway or the Website, to be acting in violation of these Official Rules, or to be acting in an unsportsman-like or disruptive manner, or with the intent to disrupt or undermine the legitimate operation of the Giveaway, or to annoy, abuse, threaten or harass any other person, and Sponsor reserves the right to seek damages and other remedies from any such person to the fullest extent permitted by law.
