Official Rules

No Purchase Necessary to Enter or Win. A purchase will not increase your chances of winning.

This promotion is in no way sponsored, endorsed or administered by, or associated with, Instagram or any other social network or platform. You understand that you are providing your information to Sponsor, and not to Instagram or other social network or platform.

1. ELIGIBILITY.

The #WithTaskRabbit Giveaway (“Giveaway”) open only to those who participate fully on one of the Instagram Posts announcing the Giveaway (on either the Instagram account of Influencer Erin Wheeler or TaskRabbit) and who are 18 as of the date of entry, lawful US residents, and have internet access (“Entrants”). Giveaway is void where prohibited by law. Giveaway is sponsored by TaskRabbit, Inc., 425 Second Street, 5th Floor, San Francisco, CA 94107 (“Sponsor” or “TaskRabbit”). 2. SWEEPSTAKES PERIOD.

The Giveaway begins at 12:01 a.m. Pacific Standard Time (“PST”) on December 16, 2017 and ends at 11:59 a.m. PST on December 18, 2017 (the “Giveaway Period”).

3. HOW TO ENTER.

The Giveaway must be entered via Instagram- At the beginning of the Entry Period, entrant may enter the Instagram Sweepstakes by liking the giveaway commencement post, tagging at least one friend, and following @TaskRabbit on Instagram. These actions can be performed on the giveaway commencement post on the Instagram account of the Influencer [@sunnycirclestudio] or the Instagram account of TaskRabbit [@TaskRabbit]. The use of an agency or any automated system to enter is strictly prohibited and Sponsor reserves the right to disqualify any entries received through such methods, as determined by Sponsor, in its sole discretion.

The entry must fulfill all giveaway requirements, as specified, to be eligible to win a prize. provision of incorrect or otherwise non-functioning contact information. If the selected winner cannot be contacted, is ineligible, fails to claim the prize within 15 days from the time award notification was sent, or fails to timely return a completed and executed declaration and releases as required, prize may be forfeited and an alternate winner selected.
