

TaskRabbit and CB2 Gift Card Giveaway Sweepstakes

Official Rules

This promotion is in no way sponsored, endorsed or administered by, or associated with, Facebook or any other social network or platform. You understand that you are providing your information to Sponsor, and not to Facebook or other social network or platform.

1. ELIGIBILITY.

The TaskRabbit and CB2 Gift Card Giveaway Sweepstakes ("Sweepstakes") open only to those who sign up at the online Sweepstakes page and who are 18 as of the date of entry (Entrants). The Sweepstakes is only open to legal residents of US and is void where prohibited by law. Sweepstakes is Sponsored by TaskRabbit, Inc., 425 Second Street, 5th Floor, San Francisco, CA 94107 and CB2 ("Sponsors"). Employees of Sponsor, its parents and subsidiaries, advertising and promotion agencies and all other entities participating in the design, promotion, marketing, advertising, administration or fulfillment of this Sweepstakes and their immediate families are ineligible to participate in this Sweepstakes. Void wherever else restricted or prohibited by law. By participating in this Sweepstakes, each Entrant hereby acknowledges that they have read, accept and agree to be bound by these Official Rules.

2. SWEEPSTAKES PERIOD.

The Sweepstakes begins May 22, 2017 12:00 AM CST and ends June 22, 2017 at 11:59 PM CDT (the "Sweepstakes Period").

3. HOW TO ENTER.

The Sweepstakes must be entered by submitting an entry using the online form provided on this Sweepstakes site. The entry must fulfill all Sweepstakes requirements, as specified, to be eligible to win a prize. Entries that are not complete or do not adhere to the rules or specifications may be disqualified at the sole discretion of TaskRabbit. You may enter only once and you must fill in the information requested. You may not enter more times than indicated by using multiple email addresses, identities or devices in an attempt to circumvent the rules. If you use fraudulent methods or otherwise attempt to circumvent the rules your submission may be removed from eligibility at the sole discretion of TaskRabbit.

4. ODDS.

Odds of winning a prize depend on the number of eligible entries received.

5. SELECTION AND NOTIFICATION OF SELECTED ENTRANT.

A random drawing will be conducted on or about June 24, 2017 by Sponsor from all eligible entries received. Odds of winning depend on the number of eligible entries received. Potential Grand Prize winner will be notified via email on or about June 24, 2017. Entrants are responsible for insuring that all e-mail information is up-to-date and accurate. Return of any prize notification email as non-deliverable will result in disqualification and an alternate winner will be randomly selected. 6. PRIZES.

Winners will receive \$500 TaskRabbit credit (or \$500 Amazon gift card) and \$1000 CB2 gift card. Actual/appraised value may differ at time of prize award. The specifics of the prize shall be solely determined by the Sponsors. No cash or other prize substitution permitted except at Sponsor's discretion. The prize is nontransferable. Any and all prize related expenses, including without limitation any and all federal, state, and/or local taxes shall be the sole responsibility of the winner. No substitution of prize or transfer/assignment of prize to others or request for the cash equivalent by winners is permitted. Acceptance of prize constitutes permission for TaskRabbit to use winner's name, likeness, and entry for purposes of advertising and trade without further compensation, unless prohibited by law.

7. CONDITIONS.

All federal, state or other tax liabilities (including income taxes) arising from this Sweepstakes will be the sole responsibility of Selected Entrant and Selected Entrant may be issued an IRS Form 1099 for the ARV of any awarded prize. By entering, you consent to jurisdiction in San Francisco, California for the resolution of any and all disputes. Should a dispute arise regarding the Sweepstakes, Entrant and Sponsors shall engage in good faith, informal dispute

resolution for a minimum period of thirty (30) days to resolve the dispute. Should the Entrant and Sponsors fail to resolve their dispute informally, they shall engage in mediation with JAMS, at their joint and equal expense. Should the mediation fail to resolve the dispute, Entrant and Sponsors shall thereafter engage in binding arbitration with JAMS. To ensure minimal cost, the arbitration shall be in front of a single arbitrator and shall be conducted in accordance with JAMS' Optional Expedited Arbitration Procedures. The binding arbitration shall be at Sponsors and Entrant's joint and equal expense, with attorneys' fees and costs to the prevailing party upon conclusion.

9. GENERAL CONDITIONS.

By participating, Entrants agree to be fully and unconditionally bound by these Official Rules and the decisions of Sponsors and waive any right to claim ambiguity in the Sweepstakes or these Official Rules. Any portion of the Sweepstakes may be canceled, suspended and/or modified, in whole or in part, if in Sponsor's opinion any fraud, technical failure or other factor beyond our control impairs the integrity or proper functioning of the Sweepstakes. Sponsors reserves the right in its sole discretion to disqualify any individual who is found to be tampering with the entry process or the operation of the Sweepstakes or the Website, to be acting in violation of these Official Rules, or to be acting in an unsportsmanlike or disruptive manner, or with the intent to disrupt or undermine the legitimate operation of the Sweepstakes, or to annoy, abuse, threaten or harass any other person, and Sponsors reserves the right to seek damages and other remedies from any such person to the fullest extent permitted by law.
